

EFLA Congress – 18-19 September 2025

Terms & Conditions

Terms & Conditions: The Congress and/or the Networking Dinner total fee to be paid includes Italian VAT (22%) and any transaction costs. The Congress fee includes registration and access to the EFLA (European Food Law Association) Congress on Thursday and Friday, 18-19 September 2025, and relevant documents for the event, if available. The Networking Dinner fee includes dinner at the selected place by the organiser. Registration is accepted and confirmed only after completing the payment through the online platform (Eventbrite), and after the position of the registering participant within their organisation has been evidenced or verified. The organisers reserve the right to reject applications at full discretion, in which case funds will be returned.

<u>Tickets</u>: EFLA events are open to the public; however, EFLA members benefit from preferential rates for purchasing tickets for EFLA events. Participants not being EFLA members are invited to purchase tickets for non-members.

<u>Payment</u>: Payment must be made via Eventbrite. Any difficulties experienced with registration should be reported to the Congress organisers at <u>communications@efla-aeda.org</u>. All efforts will be made to assist registering participants with their registration.

<u>Cancellation policy</u>: In case of a participant's cancellation until 14 days before the event, 50% of the price will be reimbursed. After that day, the costs will not be reimbursed.

Name changes: Registered participants who are unable to attend the Congress may nominate (free of charge) a substitute participant by notifying the organisers in writing until 7 days before the event, at <u>communications@efla-aeda.org</u>.

<u>Programme</u>: The Congress programme and speakers are those confirmed at the time of the event. The organisers cannot be held responsible for the non-attendance of any speakers for reasons beyond their control.

<u>**Presentations**</u>: In line with the spirit of EFLA events, presentations made at the EFLA Congress will only be available to the registered participants that attended the event. With the agreement of speakers, presentations are sent to participants after the event in a protected PDF format. Presentations about or on behalf of EFLA are agreed upon by the EFLA Board of Directors.
